7.1 Minute-book of the society/trust, containing various resolutions regarding the proposed teacher education course.

7.2 Documents under which the institution obtained ownership/long-term lease.

7.3 Documents under which the institution obtained temporary rented accommodation, pending construction of institutional building on permanent location.

7.4 Permissions (i) to divert the land for other than agricultural use, (ii) to construct the institutional building on permanent location as well as temporary location, if any, (iii) to occupy the completed institutional building and (iv) to use the institutional building for educational purposes.

7.5 Approved construction plan of the institutional building on permanent location as well as temporary location, if any. In case multiple courses are conducted from the same institutional building, the management be asked to demarcate the area in a copy of approved building plan where the proposed teacher education course will be conducted.


7.6 Document showing the newspaper advertisements for appointment of teaching and non-teaching staff, constitution of selection committees, proceedings of selection committees, select list and its approval by the society/trust and consent obtained from selected staff.
